Helpful hints on filling out the Crime Activity Form:

Feel free to make copies and use as many sheets as you need to accurately describe what you are observing.

Read the Form thoroughly. Either type or print clearly.

- Start with the **Type** of crime you are reporting. Do not write any descriptions of locations, there is a specific section for that farther down the report.
- Enter the **Date** and **Time** the activity started and ended. If time is known.
- **Location** where occurred: EXAMPLE: 1234 SW Court Ave, 100 block NW 12th St.
- **Intersection:** EXAMPLE: SW Goodwin Ave and SW 10th St.
- Enter Description of residence in the **Additional Comments.**
- **Number Involved:** How many were Adults, Juveniles, male or female, describe head to toe (approximate weight, height, color of hair, the length, color/type of cap/hat, color/type coat, color/type of shirt, color/type of pants/jeans, color/type of footwear)
Or if a dog complaint how many dogs and their descriptions (breed if known, color, color of collar if wearing one).
- Describe vehicle(s)
 - **Color** (red, blue, black, if has a white door or red door enter that in the description field).
 - **Year** (if known).
 - **Make** (Ford, Chevrolet, Chrysler, Geo, Jeep, etc).
 - **Model** (Bronco II, S10, Cherokee, etc), **Style** (Pickup, 2 Door Sedan/Pickup, etc).
 - **State** where License plate is from, please abbreviate (OR for Oregon, etc).
 - **License Plate** number (ABC123, AB12345, etc) or you can also enter Temporary Sticker information here (A1234567).
 - **Other Description** (2 flat tires, 1 red door, rear window cracked, etc).
