This permission is given voluntarily and is hereby effective until revoked in writing. Individuals committing Criminal Trespass or any other crime on these premises may be arrested. Enforcement action will be carried out at the officers’ discretion.

THIS BUSINESS, IN COOPERATION WITH THE PENDLETON POLICE DEPARTMENT, CONSIDERS OFFICERS OF THE PENDLETON POLICE DEPARTMENT "PERSONS IN CHARGE" OF THIS PROPERTY AS DEFINED IN ORS 164.205. INDIVIDUALS WHO ARE IN OR UPON THESE PREMISES AFTER NORMAL BUSINESS HOURS WITHOUT AUTHORIZATION MAY BE ARRESTED FOR CRIMINAL TRESPASS, OR MAY BE EJECTED FROM THE PROPERTY AND EXCLUDED FROM ENTERING OR REMAINING IN OR UPON THE PREMISES INDEFINITELY.
